

## Green Valley High School Alumni Foundation Dream Car Drawing Official Rules

**GVHS Alumni Foundation Dream Car Drawing** – Sponsored by Green Valley High School Alumni Foundation, a 501(c)(3) nonprofit organization. Consult with your tax professional to determine the effect of purchasing a ticket for the drawing or making a donation.

**CONSUMER DISCLOSURE:** One (1) Grand-Prize will be awarded consisting of one 2018 Chevrolet Camaro. Odds of winning - one (1) in five thousand. One (1) Second prize will be awarded consisting of \$1,000.00. One (3) Third prize will be awarded consisting of \$500.00. **1. Eligibility.** The 2018 Green Valley High School Alumni Foundation Dream Car Drawing is open only to legal residents of the U.S. and Canada (except Quebec) and to residents of other countries and U.S. territories and possessions where permitted by law. Void in Guam, the U.S. Virgin Islands, and all other U.S. territories and possessions and where prohibited by law. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**2. Sponsor/Administrator.** The sole and exclusive Sponsor and Administrator of Green Valley High School Alumni Foundation Dream Car Drawing is the Green Valley High School Alumni Foundation ("Sponsor").

**3. Timing.** The 2018 Green Valley High School Alumni Foundation Dream Car Drawing commences on April 1, 2018 and ends on December 6, 2018.

**4. How to Enter.** Purchase a ticket from an individual Green Valley High School Alumni Foundation Board Member. Tickets are sold at Green Valley High School office and at various events held at the school such as games, concerts, Open House, etc.

**6. Winner Selection Drawing.** The drawing will be conducted on December 6, 2018 by random selection. You do not need to be present to win.

**7. Winner Notification.** The winners will be notified using the contact information entered on the entry form, within three (3) business days from the drawing. If Administrator is unable to contact any of the winners or if an Entrant fails to respond to the Administrator's initial contact within three (3) business days of notification or return of e-mail notification as undeliverable after three (3) attempts, Entrant will be disqualified and an alternative winner will be notified as the new Conditional Grand Prize Winner.

**8. Verification of Conditional Winners.** CONDITIONAL WINNER OF DRAWING IS SUBJECT TO VERIFICATION BY SPONSOR. Entrant(s) selected as Conditional Grand-Prize Winner(s) will be contacted within 3 business days following notification and will be required to sign and return to Administrator, within 7 days of the date notice is sent, a notarized affidavit of eligibility, a notarized prize selection affidavit, IRS W-9 form, liability/publicity release (except where prohibited). If a Conditional Grand-Prize Winner cannot be contacted, fails to sign and return the above required documents, or if the prize or prize notification is returned as undeliverable, the Grand-Prize Winner will forfeit the prize.

**9. Odds of Winning.** Odds of winning = One (1) divided by 5,000 or the total number of tickets sold (maximum 5,000)

**10. Grand-Prize.** 2018 Chevrolet Camaro - One (1) Grand-Prize will be awarded. The Grand-Prize consists of one 2018 Chevrolet Camaro (approximate value \$28,000). The Grand-Prize awards will take place at a location and date determined solely by the Sponsor. Grand-Prize winner may elect to take cash payout in the amount of \$15,000 in lieu of the 2018 Chevrolet Camaro. **If ticket sales are less than the value of the car the Green Valley High School Alumni Foundation will disperse prize money in the following manner: Green Valley High School Alumni Foundation will retain 50% of the revenue generated by ticket sales. The third prize winner will receive \$500, the second prize winner will receive \$1,000 and the Grand-Prize Winner will receive the remaining funds. Example: If the Giveaway generates \$15,000 in ticket sales, the Green Valley Alumni Foundation will retain \$7,500, third prize winner would receive \$500, second prize winner would receive \$1,000, and the Grand-Prize Winner would receive \$6,000.** Grand-Prize Winner is responsible for all taxes resulting from winning the Grand-Prize including all federal, state and local, taxes, fees, assessments and like charges as well as purchasing license plate tags, and any fees associated with securing a legal title to the vehicle. **14. Limitations of Liability.** If for any reason an entry or ticket is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Entrant's sole remedy is another similar entry or ticket in the Green Valley High School Alumni Foundation Dream Car Drawing, provided that if it is not possible for Sponsor to award another entry due to discontinuance of the drawing, or any part of it, for any reason, Sponsor, at its discretion, may elect to hold a random drawing from among all valid entries received for the Green Valley High School Alumni Foundation Dream Car Drawing up to the date of discontinuance for any or all of the prizes offered.
